For your information the Environmental Assessment Team did not refuse the request but referred the inquirer to the Yellow Pages which is the basis that we have worked on for years as the Council does not have a panel of providers for arborists. We have attempted to have one set up but as our requirement was only for reference Council's contract management section did not want to go to the trouble of going through the process to set the panel up. We would prefer to give out a list but were instructed not to do so as it would leave Council open to criticism of favouring specific companies.

If you wish to avoid this criticism you could add a couple more as I know it is extremely difficult to get Adam Tom at short notice. A couple more are Russell Pratt, R M Pratt Arboricultural Services (T32067961) and Andrew Stovell, Landzone (T38290000).
